



- We would also like to bring something to your attention. No. 27 of the Report Summary instructions asks for the sum of Nos. 11, 17 & 24. If No 7 is an amount which includes a previously incurred expense (paid and incurred amounts are totaled on CD3), and this is added to No. 24 (which also includes a previously incurred amount), it will appear that the committee intends to spend or will spend twice the amount it will actually spend.
