

LOCAL CAMPAIGN FINANCE REPORTING WAIVER

The Missouri Association of County Clerks and Election Authorities adopted the following resolution at their annual meeting in September 2003.

Now therefore be it resolved, that the Missouri Association of County Clerks and Election Authorities encourages the Missouri Ethics Commission to maintain a free voluntary electronic filing program whereby those local election authorities who choose to participate will be relieved of the obligation to maintain a paper copy report of certain campaign finance committees obligated to file copies of reports with both the local election authority and with the Missouri Ethics Commission, provided the campaign finance committee signs an agreement to file all future campaign finance reports with the Missouri Ethics Commission in the Commission's approved electronic format.

Note - The below listed county clerks and election authorities have agreed to waive the dual filing requirement for campaign finance committees in their jurisdiction provided the committee signs an agreement with the Commission to file all future campaign finance reports only in the Commission's approved electronic format.
