The Missouri Ethics Commission, at its December 6, 2007 meeting, took the following actions:

The following case was dismissed against this Respondent as the allegation was unsubstantiated:

07E114 Mona Smith, Dade Co.

The Commission held the following hearings and ruled as follows:

05A121 26<sup>th</sup> District Senatorial Legislative Committee; Dwight Scharnhorst, Treasurer Chapter 130 RSMo.

The Commission accepted a signed Joint Stipulation of Facts and imposed a penalty in the amount of \$26,500.00. If respondent pays a fee of \$2,650.00 within 45 days and stays violation free for two years, the remainder of the penalty will be stayed.

This Order was withdrawn pursuant to a Settlement Agreement between the parties on June 5, 2008.

<u>06A235 Committee to Elect Pat Riley Sheriff; Pat Riley, Treasurer</u> Chapter 130 RSMo. The Commission ordered a penalty of \$4,000.00. The respondent is to file all reports and stay violation free for two years.

06A134 Herman Larry Buie, Sr., Candidate Chapter 130 RSMo.

The Commission ordered a penalty of \$2,000.00. If respondent pays a fee of \$200.00, files all reports within 45 days and stays violation free for two years, the remainder of the penalty will be stayed.

<u>07A013 6<sup>th</sup> Ward Democratic Organization; Mary Entrup, Treasurer</u> Chapter 130 RSMo. The Commission ordered a penalty of \$3,000.00. If respondent pays a fee of \$300.00, files all reports within 45 days and stays violation free for two years, the remainder of the penalty will be stayed. The Commission approved the following Joint Stipulations of facts, waiver of hearing before the Missouri Ethics Commission, and joint proposed Consent Order with findings of fact and conclusions of law:

## 06A183 Missouri Leadership Fund; John Elliott, Treasurer Sections 130.046 and 130.021, RSMo.

The Commission signed a joint stipulation of facts, waiver of hearing before the Missouri Ethics Commission and Consent Order with Joint proposed findings of fact and conclusions of law and ordered a penalty of \$4,000.00. If respondent pays a fee of \$500.00 within 30 days of the date of issuance of the Commission's Consent Order, the remaining \$3,500.00 fee will be waived by the Commission.

## 06A236 Timothy Harris Sections 130.011(9), 130.046.1, and 130.046.3, RSMo.

The Commission signed a joint stipulation of facts, waiver of hearing before the Missouri Ethics Commission and Consent Order with Joint proposed findings of fact and conclusions of law and ordered a penalty of \$3,000.00. If respondent pays a fee of \$300.00 within 45 days and stays violation free for two years, the remainder of the penalty will be stayed.

## 05E122 Scott Burnett

The Commission signed a joint stipulation of facts, waiver of hearing before the Missouri Ethics Commission and Consent Order with Joint proposed findings of fact and conclusions of law and ordered a penalty of \$3,500.00 within 45 days.
