The Commission approved the following Consent Order:

07A055 and 07A056 Yaphett El-Amin, El-Amin for Senate and Committee to Elect El-Amin for State Representative, St. Louis Co., Sections 130.031.2, 130.041.1(3) and (4), 130.021.2, 130.046.7, 130.021.8 and 130.031.3 RSMo.

The Commission ordered Yaphett El-Amin to pay a fee of \$50,000 on each case pursuant to Section 105.961.4(6). However, if Yaphett El-Amin pays a fee of \$5,000 on each case within 90 days of the date of the Consent Order, the remainder of the fee will be stayed subject to the following provisions. The Respondent must become fully compliant with the campaign finance reporting requirements within 90 days of this Consent Order and the Respondent must not commit any further violations of the campaign finance laws pursuant to Chapter 130 RSMo.

07A020 AND 07A021 Tom Wyrsh, Section 130.021.4 RSMo.

The Commission ordered the Respondent to pay a penalty fee of \$1,000.00 if Respondent does not stay compliant for two years. If Respondent stays compliant for two years, there will be no penalty.

06A186 Leonard Hughes, Section 130.034 RSMo. The Commission ordered the Respondent to pay a penalty of \$13,000.00.

06A252 Karla May, Section 130.046.1(2), 130.032.1(3), 130.032.2 and 130.041.1(3) and (4) RSMo.

The Commission ordered the Respondent to pay a penalty fee of \$3,540.00. However, if Respondent pays \$500.00 of that fee within 45 days of the signing of the Consent Order, the \$3,040.00 of the remaining penalty will be stayed for two years, subject to the specific terms of the Joint Stipulation, and the Respondent is ordered to comply with all provisions of Chapter 130 RSMo.
