## 2014 Election News

### ATTN: Officials Accepting Declarations of Candidacy

Packets for 2014 Elections coming in October.

- *Review* the packet—includes instruction letter, 2014 Guide to Ethics Law, PFD forms (AOB >\$1mil) & Notice to Candidate.
- *Review* your Candidate Declaration form—may include wording that candidate has no outstanding campaign finance reports due from prior elections.
- *Remember*, [§130.071 RSMo](#) has restrictions for candidates taking office until all reports are filed.

***Be sure to discard all old election materials.***

## Political Subdivisions

Beginning **November 16, 2013**, if AOB over \$1 million, political subdivisions will be able to [electronically](#) submit their list of required annual PFD filers to MEC. (Emails will be received at the end of October containing password information).

Both last year's annual filers and last year's candidates will be displayed. Carefully review each section, update each filer, and remove those no longer required to file.

Each subdivision must notify those people whose names have been submitted. They are required to file their PFD by May 1, 2014 or earlier if a candidate.

## Use of Public Funds

Elected and public officials, their staff and employees are prohibited from using public funds to advocate, support or oppose ballot measures or candidates.

Examples: staff's time at work, office copiers, fax machine, paper, computers, printers, etc.

Public Funds may be used to make public appearances and/or issue press releases. (§115.646 RSMo & AG Opin 54-90).

office, the general assembly, or for a municipal office in a city with a population of more than 100,000, make sure you know all the requirements if you choose to file as an exempt candidate.

## Lobbyist Renewal Reminders

- Lobbyist renewal period begins Dec 1, 2013 and runs through Jan 5, 2014.
- All lobbyists must renew their registration and pay a \$10 registration fee.
- Lobbyists who fail to renew by Jan 5 will be terminated retroactive to Dec 31, 2013.



## Campaign Finance Disclosure Reminders

File an [Amended Statement of Committee Registration](#) form to **change an election date** (changing it on reports will not update the committee information).

A **miscellaneous receipt** is money coming in other than by contribution or loan received (ex: interest earned, receipt of a rejected contribution, refund for return of merchandise, etc.).

A **miscellaneous disbursement** is money spent other than by expenditure or contribution made (ex: rejecting a contribution (that's already been deposited) back to the original contributor, transfer of funds from one candidate committee to another controlled by the same candidate, etc.).

A donation given to a charity or similar type event is reported as an **expenditure made**; however, a contribution from one candidate or committee to another candidate or committee is reported as a **contribution made**.

If a committee files a *48 Hour Report of Contribution over \$5,000* or a *Late Contribution Report*, these contributions must **also be included** in the committee's next full campaign finance disclosure report.
