Mandatory Quarterly Reports—(§ 130.046.1(3) & 130.046.3, RSMo)

Filed by all committees by the 15th day following the close of each calendar quarter until the committee terminates.

40 Day Before Election Report—(§ 130.046.1(3), RSMo)

Only required if your committee accepted contributions or spent money (made expenditures (paid or incurred) or made contributions) for the election.

Only required if your committee spent money (made expenditures (paid or incurred) or made contributions) for the election

30 Day After Election Report—(§ 130.046.1(2), RSMo)

Only required if your committee spent money (made expenditures (paid or incurred) or made contributions) for the election. If this report is required, it must be filed prior to taking office. If debt exceeds \$1,000, the committee may not file a *Statement of Limited Activity* for this report.

48 Hour Report of Contribution Over \$5,000—(§ 130.044.1, RSMo)

Any individual or committee that receives a single contribution (including a loan)* from a contributor in an amount over \$5,000 must electronically report the contribution to the Missouri Ethics Commission within 48 hours of its receipt. This contribution must also be included in the committee's next filed report. Late filing results in \$10 per day late fees.

24 Hour Notice of Late Contribution Received—(§ 130.050.3, RSMo)

Any receipt of a contribution (including a loan)* in an amount over \$250 that is received less than 12 days before the election, must be reported within 24 hours of its receipt. This contribution must also be included in the committee's next filed report.

24 Hour Late Expenditure Report for Continuing Committees (PACs)—(§ 130.046.3(2), RSMo)

Each time a continuing committee (PAC) aggregates more than \$250 in expenditures made/incurred (not including contributions made to candidates or other committees) less than 12 days before an election, a full disclosure report must be filed within 24 hours. Late filing results in \$10 per day late fees.

Timely Filing: Electronically filed reports must be filed by the due date. If the deadline would fall on a Saturday, Sunday, or official holiday, it is extended to the next business day (unless the report/notice would be due less than eight days before an election, in which case there are no extensions).

Campaign Committees: For ballot measures to be qualified on the ballot by initiative petition, see also § 130.046.2, RSMo.
