



# MEC Deadlines and Timeline

## April 2, 2024, Election

### Personal Financial Disclosure

- Due: 1/9/2024
- After 1/9/2024—Late fees at \$10 per day
- After 1/16/2024—Late fees, potential disqualification, and removal from the ballot

### January Quarterly Report (mandatory)

- Close: 12/31/2023
- Due: 1/16/2024

### 40 Day Before Election Report

- Close: 2/17/2024
- Due: 2/22/2024

Only required if your committee accepted contributions or spent money (made expenditures (paid or incurred) or made contributions) for the election.

### 8 Day Before Election Report

- Close: 3/21/2024
- Due: 3/25/2024

Only required if your committee spent money (made expenditures (paid or incurred) or made contributions) for the election.

### Election Day—April 2, 2024

### April Quarterly Report (mandatory)

- Close: 3/31/2024
- Due: 4/15/2024

### 30 Day After Election Report

- Close: 4/27/2024
- Due: 5/2/2024

Only required if your committee spent money (made expenditures (paid or incurred) or made contributions) for the election. If this report is required, it must be filed prior to taking office. If debt exceeds \$1,000, the committee may not file a Statement of Limited Activity for this report.

### Unsuccessful candidate committee and campaign committee termination deadline

- 5/2/2024

Unsuccessful candidate committees must terminate their committees within 30 days of their election date. Campaign committees must terminate within 30 days of their election date or upon the resolution of debt.

### 2024 Quarterly Reports

Quarterly reports are mandatory for all active committees and must be filed until the committee terminates.

- January Quarterly Report—Closes: 12/31/2023; Due: 1/16/2024
- April Quarterly Report—Closes: 3/31/2024; Due: 4/15/2024
- July Quarterly Report—Closes: 6/30/2024; Due: 7/15/2024
- October Quarterly Report—Closes: 9/30/2024; Due: 10/15/2024



# Supplemental Reporting

## **48 Hour Report of Contribution over \$5,000** (file as needed)

- Any individual or committee that receives a single contribution over \$5,000 (including a loan, see 130.011, RSMo, for the full definition of contribution) must electronically report the contribution to the MEC within 48 hours of its receipt.
- This contribution must also be included on the committee's next filed report.
- Late filing results in late fees of \$10 per day.

## **24 Hour Notice of Late Contribution Received** (file as needed)

- Any receipt of a contribution over \$250 (including a loan, see 130.011, RSMo, for the full definition of contribution that is received less than 12 days before an election, must be reported within 24 hours of its receipt.
- This contribution must also be included on the committee's next filed report.

## **24 Hour Late Expenditure Report (PACs only)** (file as needed)

- Each time a continuing committee (PAC) aggregates more than \$250 in expenditures made (not including contributions made to candidates or other committees) less than 12 days before an election, a full disclosure report must be filed within 24 hours.
- Late filing results in late fees of \$10 per day.



# Additional Information

## **Electronic Filers:**

Electronic reports must be filed by the due date.

## **Weekends and Holiday:**

If the due date for filing a report falls on a Saturday, Sunday, or an official state holiday, the deadline is extended to the next business day (unless the due date is less than 8 days prior to an election, in which case no extension applies).

## **Paper Filers (local ballot measure committees and PFD filers)**

- Mailed reports must be post-marked prior to the due date.
- Hand delivered reports must be received by 5:00 p.m. on the due date.
