The Commission approved the following Joint Stipulations of facts, waiver of hearing before the Missouri Ethics Commission, and joint proposed Consent Order with findings of fact and conclusions of law:

08A083 6th District PAC Fund and Dennis Murray, Treasurer

The Commission entered a Consent Order with Proposed Findings of Fact and Conclusions of Law ("Joint Stipulaton") finding probable cause that the Respondent Dennis P. Murray and 6th District PAC violated §130.021.5, §130.041.1(3) (a), §130.041.1(8), §130.046. 1(1), §130.046. 1(2), §130.046. 1(3), and § 130.026.5, RSMo, as stated in the Joint Stipulation. The Commission ordered that a fee is imposed against the Respondents 6th District PAC Fund and Dennis Murray, Treasurer in the amount of \$16,741.00 pursuant to § 105.961.4(6) RSMo. However, if either Respondent pays \$1,674.00 of that fee within forty-five (45) days after the date of the Order, the remainder of the fee will be stayed for two years. If Respondents 6th District PAC Fund and Dennis Murray have not committed any further violations of the campaign finance disclosure laws pursuant to Chapter 130, RSMo., during the two year stay, then Respondents will not be required to pay the balance of this fee.

08E144 Karl Unsworth

The Commission entered Findings of Fact and Conclusions of Law and an Order finding probable cause that the Respondent Karl Unsworth violated §130.021.5, RSMo, as stated in the Findings of Fact, Conclusions of Law and Order. It is ordered of the Missouri Ethics Commission that the Commission issue a letter of reprimand to Respondent Karl Unsworth pursuant to § 105.9641.4 (4). The Commission also ordered that a fee be imposed against Karl Unsworth in the amount of \$1,000.00 pursuant to § 105.961.4(6) RSMo. However, if Karl Unsworth pays \$100.00 of that fee within forty-five (45) days after the date of the Order, the remainder of the fee will be stayed for two years. If Respondent Karl Unsworth has not committed any further violations of the campaign finance disclosure laws pursuant to Chapter 130, RSMo., during the two year stay, then Respondent will not be required to pay the balance of this fee.

The Commission ordered that a fee is imposed against Respondents Stephanie Noecker and Get the Facts in Shaw in the amount of \$100.00 pursuant to §105.961.4(6), RSMo.
