2021 Personal Financial Disclosure (PFD) Filing Deadlines

2021 Candidates

If you are required to file a PFD as a candidate in the April election, the due dates are:

April 6, 2021:

14-Day Deadline*

February 2, 2021

21-Day Deadline**

February 9, 2021

2021 Annual Filers

If your name was submitted to our office by a political subdivision as a person required to file a Personal Financial Disclosure (PFD) due to a position held in 2020, you must file your PFD no later than **May 3, 2021.** You should have received a letter with instructions for e-filing along with your MEC Online ID and Password.

An annual filer who is also a candidate should adhere to the earlier due date. Annual filers must file for each year (or portion of a year) for which they hold a position that requires the filing of a PFD.

POLITICAL SUBDIVISIONS:

Submit your list of candidates in the April election who are required to file a PFD with the MEC by **Friday**, **January 22, 2021.**

IMPORTANT PFD REMINDER

The MEC <u>cannot</u> enforce a political subdivision's conflict of interest ordinance.

If a political subdivision has a conflict of interest ordinance on file and PFD deadlines are not met, penalties can only be enforced by the political subdivision according to its ordinance.

Conflict of Interest FAQs

Can public officials/employees act/vote on decisions that may financially impact themselves or their family?


Public officials and employees:

Cannot participate in decisions that could provide themselves, their spouse, or their dependent children with a special monetary benefit. (See §105.452(4), RSMo for the definition of a special monetary benefit.)

Cannot use their decision-making authority to materially enrich themselves, their spouse, or dependent children for the purpose of coercing or extorting anything of actual monetary value.

Cannot attempt to influence the decision of any state or local agency when they know the decision could result in the acceptance of the performance of a service, or the sale, rental, or lease of any property to that agency for consideration over \$500/transaction or \$5,000/year to:

- Themselves, their spouse, or dependent children (unless the transaction is made after public notice and competitive bidding (other than real property), and the bid accepted is the lowest bid); or
- Any business with which they are associated (unless transaction is made after public notice or competitive bidding for other property). The official/employee's bid must be the lowest bid received.



What is governmental nepotism?

Defined in Article VII, Section 6 of the Missouri Constitution, nepotism occurs when a public official or employee in Missouri names or appoints a relative within the fourth degree of blood or marriage to public office or employment.

Violation of the Missouri Constitution leads to automatic forfeiture of office or employment.

Consult your local ordinances, policies, and procedures for any further requirements related to nepotism.

Can former officials/employees who worked in executive/ administrative capacities take positions that may influence the decisions of their former agencies/departments immediately upon leaving public employment?

No, elected and appointed officials/employees serving in an executive or administrative capacity may not be paid to perform any service for their political subdivision one year after they leave public employment, by which they attempt to influence a decision of any state agency or political subdivision in which they were an officer, employee, or over which they had supervisory authority.

Exceptions: Former officials and employees:


Can appear in an adversary proceeding.

Can prepare or file a public document.

Can be employed by another department, division, or agency of the executive branch of state government.

Contribution Limits and Lobbyist Gift Restrictions in Effect

Voters approved Constitutional Amendment 3, adjusting campaign contribution limits and prohibiting lobbyist gifts to members and employees of the General Assembly. These provisions went into effect on **December 3, 2020.**

Contribution Limits

 Amendment 3 sets new limits on the amount of contributions a state senate candidate and a state representative candidate can receive from a single contributor.

State Senate candidates: \$2,400

State Representative candidates: \$2,000

- These contribution limits apply each election cycle.
- These limits apply to exploratory committees.

Lobbyist Gifts

- Amendment 3 prohibits "gifts of tangible and intangible items, services, or things of value from paid lobbyists or lobbyist principals."
- Provisions only prohibit gifts to members and persons employed by the General Assembly.
- Candidates for the General Assembly may still accept campaign contributions according to acceptable limits.
- Individuals may still receive gifts, family support, or anything of value from relatives within the fourth degree by blood or marriage (see pg. 2).
- Lobbyists are still required to file monthly expenditure reports under §105.473, RSMo.

The 2021 January Quarterly Report is optional (but recommended, for ease of reporting). Late fees are not assessed for this report

Remember: a filer's next report must include all activity since their last report.
