Political Subdivision Reminders

I. Annual Operating Budget (AOB)

In order to identify those persons required to file a personal financial disclosure (PFD), political subdivisions must confirm whether their AOB is:

- Over \$1 million; or
- \$ I million or under

2. Conflict of Interest Ordinance/Resolution

If you do not adopt or re-adopt an ordinance, ALL elected, appointed, and decision making personnel, as well as candidates, are required to file a PFD. If you do adopt a new ordinance, or re-adopt your current ordinance, the deadline is **Sept 15th**. The ordinance must be adopted (or re-adopted) at an open meeting. A certified copy must be mailed to MEC within 10 days of the adoption (or re-adoption).

See §105.485 RSMo for minimum ordinance requirements. In addition to the minimum requirements, consider including the following:

- Penalties for failure to follow ordinance;
- Filing requirements for candidates.

E-file AOB

- Starting Tues, July 16th through Mon, Aug 5th, go to our website at www.mec.mo.gov
- Log into the <u>Political Subdivision E-Filing</u> System (use your political subdivision's log-in information)
- 3. Update subdivision contact information (if necessary)
- 4. Confirm your AOB (you will receive an email confirmation)

Tips & Reminders

Campaign Finance

- July Quarterly Report -Due July 15 (time period begins the day after the last filed report ended through June 30)
- Filing Tip Step 5 Prior
 Report Totals: Money
 on Hand at beginning
 of July Quarterly should
 match Money on
 Hand at close of last
 full disclosure report
 filed
- Do not double report activity by including it on more than one report

- Any committee that has more than \$5,000 debt must file a full disclosure report even if had no activity
- Candidates: If you have not amended your <u>Statement of Committee</u> <u>Organization</u> with a future election date you cannot take contributions
- A committee's bank account must be held in the name of the committee as it is registered with MEC

- If you participate in online banking, print a hard copy of your monthly statement for your recordkeeping
- View <u>Campaign</u> <u>Committees</u> brochure if forming committee for ballot measures

Conflict of Interest

Q: Can an elected or appointed public official receive compensation from the political subdivision for additional employment services performed for the political subdivision?

A: No, see Sections 105.454, 105.456, and 105.458 RSMo., for specific requirements.

Generally, a public official or

employee cannot be paid wages for additional services performed beyond their normal compensation. Other state law and the political subdivision laws or ordinances may establish specific compensation for an elected or appointed public official or employee; these should be consulted.
