Reminders for Political Subdivisions

Relating to Personal Financial Disclosures



Confirm your Annual Operating Budget

By **July 17, 2023**, subdivisions must confirm to the MEC whether their annual operating budget (AOB) is over \$1 million or \$1 million or under. To e-file your subdivision's AOB, log in to the subdivision's MEC account. You should receive an email with your subdivision ID and case-sensitive password.

Conflict of Interest Ordinances

Each subdivision may choose to adopt its own method of disclosing the potential financial conflicts of interest of its candidates, officials, and/or employees. Please note—the minimum requirements outlined in statute for an ordinance do not include penalties. Include any desired penalties in the ordinance. Upon adoption, the subdivision is responsible for enforcing its ordinance.

Checklist for Subdivisions:

- Confirm whether your subdivision's AOB is over \$1 million by July 17, 2023.
- Adopt , or re-adopt a conflict of interest ordinance (if desired) by September 15, 2023.
- If ordinance is adopted, send a certified copy to the MEC within 10 days.

Campaign Finance Report Filing Tip:

If you do not see the July Quarterly Report as an option when you log into the MEC filing system you may have a previous report that is still open and active. If you have a report that is currently open our system will not show you any other report options. You will need to resolve the previous report in order to move forward with the July Quarterly Report. Campaign Finance Filing Reminders:

- The July quarterly report is due on **July 17th.**
- This report is **mandatory**.
- The reporting time-period for this campaign finance report is from April 1st, or the day after your last full disclosure report was submitted, to June 30th.
- If you need your login information to file your report please reach out to our office as soon as possible.



Conflict of Interest- Frequently Asked Questions

The Missouri Ethics Commission often receives questions about matters related to conflicts of interest. To assist the public with finding answers to these types of questions we have a robust frequently asked questions <u>page</u> on our website, and you can search these by keyword. We also post all of the Commission's <u>Opinions</u> online. These reflect the commission's interpretations of our statutes.

Once you are on the frequently asked questions page of our website you can either search through them using our keyword search function, or by selecting a specific category to review. The categories are Campaign Finance, Financial Disclosure, Lobbying, Conflict of Interest or Enforcement Actions, and you can also use a keyword search within each category.

Below is an example of a frequently asked question, and a link to the relevant Commission Opinion.

Q: Can a mayor of a 4th class city also be employed as the city administrator?

A: No, a mayor cannot retain their elected position and also be employed as city administrator. Further, a mayor is prohibited from assuming another government position within that political subdivision for one year after leaving office in which they attempt to influence the city.
